Education

I reached out to MixDesign who is the company that developed the education space in hopes to start phase 2 of the project which we would like to be the entrance to the program area. Their quote was extremely high and open ended. So, in the coming months, we will be brainstorming ideas and other avenues to pursue to update the entrance.

Our Costume Swap Shop is set to open for the season on October 5. Our educators have almost finished setting up if you would like to take a look after the meeting. Please pass along information to anyone who may be interested.

For the first time since 2020, we were able to start the school year with our scheduled programs.



RESOLUTION NO. 2012-1 LAKE COUNTY SOLID WASTE MANAGEMENT DISTRICT POLICY ON NEPOTISM AND ON CONTRACTING WITH THE DISTRICT

Whereas, the Lake County Solid Waste Management District, hereinafter "District", has the powers and duties enumerated in Indiana Code 13-21-1 et. seq.; and

Whereas, as a governmental entity, the District represents the citizens of Lake County and the State of Indiana; and

Whereas, public service is one of the highest callings which demands the conduct above reproach and which avoids even the appearance of impropriety.

Now, therefore, be it resolved:

The District Board hereby finds it in the best interest of the District to adopt the following Policy on Nepotism and on Contracting with the District, which follows hereafter, as the standard by which all those representing or associated with the District in any capacity shall conduct themselves.

Lake County Solid Waste Management District Policy on Nepotism

Sec. 1. This Resolution applies to the Lake County Solid Waste Management District, hereinafter "District".

Sec. 2. An individual who is employed by the District on July 1, 2012, is not subject to this Resolution unless the individual has a break in employment with the District. The following are not considered a break in employment with the District:

(1) The individual is absent from the workplace while on paid or unpaid leave, including vacation, sick, or family medical leave, or worker's compensation.

(2) The individual's employment with the District is terminated followed by immediate reemployment by the District, without loss of payroll time.

Sec. 3. As used in this Resolution, "direct line of supervision" means an elected officer or employee who is in a position to affect the terms and conditions of another individual's employment, including making decisions about work assignments, compensation, grievances, advancement, or performance evaluation. The term does not include the responsibilities of the District Board, as provided by law, to make decisions regarding salary ordinances, budgets, or personnel policies of the District.

Sec. 4. As used in this Resolution, "employed" means an individual who is employed by the District on a full-time, part-time, temporary, intermittent, or hourly basis. The term does not include an individual who holds only an elected office. The term includes an individual who is a party to an employment contract with the District.

Sec. 5. (a) As used in this Resolution, "relative" means any of the following:

- (1) A spouse.
- (2) A parent or stepparent.
- (3) A child or stepchild.
- (4) A brother, sister, stepbrother, or stepsister.
- (5) A niece or nephew.

(6) An aunt or uncle.

(7) A daughter-in-law or son-in-law.

- (b) For purposes of this section, an adopted child of an individual is treated as a natural child of the individual.
- (c) For purposes of this section, the terms "brother" and "sister" include a brother or sister by the half blood.
- Sec. 6. (a) This Resolution establishes the District policy regarding employment of relatives. The District Board may subsequently modify this policy to:

(1) include requirements that are more stringent or detailed than any provision in this

Resolution; and

(2) apply to individuals who are exempted or excluded from the application of this Resolution.

The District may prohibit the employment of a relative that is not otherwise prohibited by this Resolution.

- (b) The annual report filed by the District with the state board of accounts must include a statement by the Chairperson of the District stating whether the District has implemented a policy consistent the requirements listed in Indiana Code 36-1-20.2.
- Sec. 7. Individuals who are relatives may not be employed by the District in a position that results in one (1) relative being in the direct line of supervision of the other relative.

Sec. 8. (a) This section applies to an individual who:

(1) is employed by the District on the date the individual's relative begins serving a term of an elected office of the District; and

(2) is not exempt from the application of this Resolution under section 2 of this Resolution.

(b) Unless a policy adopted under section 6 of this Resolution provides otherwise, an individual may remain employed by the District and maintain the individual's position or rank even if the individual's employment would violate section 7 of this Resolution.

(c) Unless a policy adopted under section 6 of this Resolution provides otherwise, an individual described in subsection (b) may not:

(1) be promoted to a position:

if the new position would violate section 7 of this Resolution.

Sec. 9. This Resolution does not abrogate or affect an employment contract with the District that:

(1) an individual is a party to; and

- (2) is in effect on the date the individual's relative begins serving a term of an elected office of the District.
- Sec. 10. Each elected officer of the District shall annually certify in writing, subject to the penalties for perjury, that the officer has not violated this Resolution. An officer shall submit the certification to the Chairman of the District not later than December 31 of each year.

Lake County Solid Waste Management District Policy on Contracting With the District

Sec. 1. This Resolution applies only to the District.

Sec. 2. As used in this Resolution, "elected official" means:

(1) the executive or a member of the executive body of the District;

(2) a member of the legislative body of the District; or

(3) a member of the fiscal body of the District.

Sec. 3. (a) As used in this Resolution, "relative" means any of the following:

- (1) A spouse.
- (2) A parent or stepparent.
- (3) A child or stepchild.
- (4) A brother, sister, stepbrother, or stepsister.
- (5) A niece or nephew.
- (6) An aunt or uncle.
- (7) A daughter-in-law or son-in-law.
- (b) For purposes of this section, an adopted child of an individual is treated as a natural child of the individual.
- (c) For purposes of this section, the terms "brother" and "sister" include a brother or sister by the half blood.
- Sec. 4. (a) This Resolution establishes the District policy regarding contracting with the District. The District Board may subsequently modify this policy to:
 - (1) include requirements that are more stringent or detailed than any provision in this

Resolution; and

(2) apply to individuals who are exempted or excluded from the application of this Resolution.

The District may prohibit or restrict an individual from entering into a contract with the District that is not otherwise prohibited or restricted by this Resolution.

- (b) The annual report filed by the District with the state board of accounts must include a statement by the Chairperson of the District stating whether the District has implemented a policy consistent the requirements listed in Indiana Code 36-1-21.
- Sec. 5. (a) The District may enter into a contract or renew a contract for the procurement of goods and services or a contract for public works with:
 - (1) an individual who is a relative of an elected official or the Executive Director; or
- (2) a business entity that is wholly or partially owned by a relative of an elected official; only if the requirements of this section are satisfied and the elected official does not violate IC 35-44-1-3.
- (b) The District may enter into a contract or renew a contract with an individual or business entity described in subsection (a) if:
 - (1) the elected official files with the District a full disclosure, which must:
 - (A) be in writing;
 - (B) describe the contract or purchase to be made by the District;
- (C) describe the relationship that the elected official has to the individual or business entity that contracts or purchases;
 - (D) be affirmed under penalty of perjury;
- (E) be submitted to the District Board and be accepted by the Board in a public meeting of the District prior to final action on the contract or purchase; and
- (F) be filed, not later than fifteen (15) days after final action on the contract or purchase, with:
 - (i) the state board of accounts; and
- (ii) the clerk of the circuit court in the county where the District takes final action on the contract or purchase;
 - (2) the District Board:
- (A) makes a certified statement that the contract amount or purchase price was the lowest amount or price bid or offered; or

- (B) makes a certified statement of the reasons why the vendor or contractor was selected; and
 - (3) the District satisfies any other requirements under IC 5-22 or IC 36-1-12.
- (c) An elected official shall also comply with the disclosure provisions of IC 35-44-1-3, if applicable.
- (d) This section does not affect the initial term of a contract in existence at the time the term of office of the elected official of the District begins.
- Sec. 6. Each elected officer of the District shall annually certify in writing, subject to the penalties for perjury, that the officer has not violated this Resolution. An officer shall submit the certification to the Chairman of the District not later than December 31 of each year.

Resolution of the Lake County Solid Waste Management District Amending Internal Controls Policy

WHEREAS, the Lake County Solid Waste Management District (*hereinafter*, District) is organized and operates under Ind. Code § 13-21-3.

The District Board interacts with the Examiners from the State Board of Accounts as directed by the State Board of Accounts. In the day to day operation of the District, there are questions which may arise for which State Board of Account input is sought. When that occurs, the District's Executive Director/Controller will contact the State Board of Accounts and seek direction and input. The State Board of Accounts has been very helpful and cooperative in reviewing the District's requests and providing input and the District looks forward to the continued successful and cooperative relationship.


The District's Director has as one of their duties the maintenance of personnel records, which are maintained under lock and key in the District's administrative offices.

The District Human Resources Policies and Procedures outlines the open communication and procedures regarding employee conduct. WHEREAS, the Town Council of the Town of Merrillville wishes acquire this Storage Building from the LCSWMD.

WHEREAS, Ind. Code §§ 5-22-22 concerns the "Disposition of Surplus Personal Property by a Governmental Body."

WHEREAS, I.C. § 5-22-22-1 is entitled "Applicability of chapter" and it provides in relevant part:

"(a) This chapter applies only to personal property owned by a governmental

body."

WHEREAS, the LCSWMD is a "governmental body" as defined by I.C. § 5-22-2-13.

WHEREAS, the Town of Merrillville, Indiana is a "municipality" as defined by I.C. § 36-1-2-11.

WHEREAS, the Merrillville Town Council is a "governmental body" as defined by I.C. § 5-22-2-13.

WHEREAS, the Board of Directors of LCSWMD is authorized to enter contracts for the LCSWMD and as such is the "purchasing agency" for the LCSWMD, as defined by I.C. § 5-22-2-25.

WHEREAS, the Merrillville Town Council is authorized to enter contracts for the Town of Merrillville, Indiana and as such is the "purchasing agency" for the Town of Merrillville as defined by I.C. § 5-22-2-25.



Resolution by the Lake County Solid Waste Management District Exercising the Second 1-Year Option of the Agreement for the District Collection, Processing, and Recycling of Electronic Waste Program 2025

WHEREAS, the Lake County Solid Waste Management District, hereinafter "District", and Green Wave Computer Recycling, LLC, hereinafter "Contractor", executed a 1-year Agreement with 2 1-year options commencing on January 1, 2023, for the operation of the District Collection, Processing, and Recycling of Electronic Waste Program, hereinafter "Program"; and

WHEREAS, the current Agreement between the Contractor and the District provides for the ability for the District to exercise its second option for the extension of the Agreement; and

LEGAL SERVICES RETAINER FEE AGREEMENT FOR 2024, 2025, AND 2026

COMES NOW, William L. Touchette (hereinafter, Attorney) and the Lake County Solid Waste Management District (LCSWMD) located at 8695 Broadway, Merrillville, Lake County, Indiana, by the Chairperson of its Board of Directors (hereinafter, Client) and hereby enter the following Agreement:

Throughout the duration of this Agreement:

- A, Client will need to receive general legal advice and opinions regarding matters that routinely arise in the course of the business affairs of the LCSWMD;
- B. Client desires to consult with Attorney and obtain appropriate legal services from Attorney regarding general and routine legal matters that may arise; and
- C. Attorney desires to provide Client with appropriate general and routine legal services including (but not limited to) legal research, legal drafting, Client consultation, attending meetings of the LCSWMD's Board; attending meetings with Client's personnel; and meeting and consulting with others on Client's behalf as circumstances reasonably require.

Attorney and Client agree that Attorney will provide Client with the above described general and routine legal services for an annual retainer of \$15,000.00, which shall be paid by Client to Attorney on a monthly basis at the rate of \$1,250.00 per month. For said retainer Attorney shall provide Client with the above-described legal services based on an average of eight (8) hours per month.

Attorney and Client agree that if Client wants Attorney to provide legal services regarding extraordinary legal matters that may arise in the course of Client's business affairs, then Attorney and Client will enter a separate contractual agreement under which Attorney will provide those extraordinary legal services.

Attorney will not bill Client for any extraordinary legal services without the prior agreement and consent of Client.

This Agreement shall be in effect from 1-1-2024 through 12-31-2024.

This Agreement shall automatically renew for 1-1-2025 through 12-31-2025, and renew again for 1-1-2026 through 12-31-2026 unless prior to the end of 2025 or 2026 one of the parties gives notice to the other that this Agreement shall not be renewed.

Either party may terminate this Agreement upon two (2) months written notice to the other party.
