OLD BUSINESS: Board and Committee Reports

Chairman-Chairman Hamm, I didn't know I was going to be the Chair. I do not have a report.

Executive Director's Report – Jeanette Romano – Please see attached report.

Kiera Hagerman, Education and Public Information Programs Manager, presented - CAPS to Benches Program The District will sponsor this program again this year. GreenTree Plastics has made changes to the program that includes requiring all groups actively include children and/or students in collecting and sorting the caps; they don't want it to be adults. We will share that information with the groups who register. The Team decided that a minimum of 10 groups would be needed to participate and a maximum of 15 groups has been set in order to stay within our budget. Cap drop off and bench pick up will be the third week of June 2019.

Composting Operations – The office/storage trailer was delivered in December. Electric was installed earlier this month by Meade Electric. We are waiting for the City of Gary to perform an inspection before NIPSCO can install the meter and power.

Cliff Duggan, Director of Business Operations and Governmental Affairs, presented — We followed through with the Board's direction at the November meeting and put out the Solicitation of Bids Sale of Used Leaf Vacs (2). We solicited five (5) companies and sealed bids were due today, January 17, 2019. Responses for purchase were received from Bob's Tree Service for \$1500 and PBS was at \$1250. My recommendation to the Board would be to award the sale to Bob's for \$1500 and that should they fail to fulfill the terms, obviously then I would recommend that it go to the second bidder. But they are to provide a certified check to the District and in talking with Bob's Tree Service it is my understanding that Bob's has the check today; and then they have 30 days, pursuant to the notice, to take the leaf vacs.

MOTION by Councilmember Long to sell the leaf vacs (2) under the conditions set forth to Bob's Tree Service for \$1500, and second by Councilmember Corn. **MOTION PASSES**, unanimously by voice vote.

MOTION by Councilmember Carnahan to adopt the Executive Director's report, second by Councilmember Clemons. **MOTION PASSES**, unanimously by voice vote.

Legal/Legislative Report – Cliff Duggan – SB314 is currently pending and was introduced by Senator Niemeyer. It applies only to and seeks to take away the property tax authority only for Lake County Solid Waste Management District. All the other 71 other solid waste districts (some are multi-county districts) are special taxing districts and have that authority. Approximately 50% of the districts currently are either totally or partially funded by property tax. I expect that there could be times we will need to appear before the Tax and Finance Committee to testify against SB314. I will keep you informed on the development of SB314 as we move through the session.

MOTION by Vice Chairwoman Cid to adopt the Legal/Legislative Report, second by Councilmember Clayton. **MOTION PASSES**, unanimously by voice vote.

Citizens Advisory Committee – We held a meeting with a general roundtable discussion. We are looking for more members if anyone knows of someone who would be interested. We currently have five (5) members.

Chairman Hamm – We appreciate what you do.

Finance/Recycling Grants Committee - No report

Other Committee Reports – Councilmember Carnahan spoke about the 16+ meeting on January 25 at Schererville Town Hall at 9:00 am with Tim Brown, Economic Development Committee; topic is applying for [Community Block] Grants.

Leaf Vac Collection Responses and Contract Award – Jeanette Romano - The bids received are as follows:

Bob's Tree Service: \$131,000 first year, \$132,310 second year, \$133,633 third year = \$396,943 three year contract.

PBS Enterprises: \$133,600 x 3 years = \$400,800 three year contract

Bob's is lower by \$3,857 over the potential 3-year term of the contract.

It's a 3-year contract; one year with two renewable years. Both bidders are providing service for the entire areas currently covered by the district and described on the district website. Including those areas currently designated as ancillary areas. Both bidders will provide under roof storage of the four leaf vacs.

After our discussion at our last board meeting, the responses to the input that came from the board, and issues that I remembered but didn't have all the information to speak publicly, we went back and did some research. I contacted our former Executive Director, John Minear, to ask him some questions about his concerns. After that discovery, this is what his concerns were: Bob's had told him that on several occasions, at the end of the prior contract, that they would clean one of the leaf vacs but had failed to do so. They had cleaned the other three. Mr. Minear had witnessed on several occasions at the district compost site that Bob's workers were not working efficiently, specifically they had on occasion sat in their truck longer than necessary after dumping the leaves. At another time, Mr. Minear witnessed one of three of Bob's workers, the oldest, perform all of the work; dumping the leaves from the leaf vacs while the other two workers stood and watched. I had remembered about the leaf vac that wasn't cleaned. I remembered about them taking more time at the site, but I didn't remember the particulars of why and about the older gentleman. I present these facts to you so you can make an informed decision.

Cliff Duggan – The board is free to choose one of the following options for its actions: 1) either award to the lowest responsive and responsible bidder; or 2) it can throw out all the bids and re-bid. The leaf vac service doesn't start until October of this year, so we have time if the board chooses to do that.

However, if the board chooses to award the contract tonight, the following is respectfully submitted for the board's consideration. The board has heard and received the facts and consideration of this award through 1) summary of the bids provided in your agenda packet; 2) information provided by Jeanette and me through the discussion at this and prior district board meetings; and 3) there's information which individual board members may have through their involvement as board members.

So based on that, the board may find and act as it chooses as follows: 1) find that Bob's Tree Service's bid is lowest bid and that Bob's is a responsive and responsible bidder and award the contract to Bob's. OR 2) find that based on the information provided, including the information to which Jeanette referred that was from prior Executive Director, John Minear, the board would find based on that that Bob's is no a responsible bidder and find that PBS then is the lowest responsive and responsible bidder and award the contract to PBS.

So those are the three options that the board has, and again it is at the board's pleasure.

MOTION by Councilmember Clemons to award to PBS due to the facts that we have right here in that of the inconsistency of the service, second by Vice Chairwoman Cid. Discussion held.

Councilmember Clemons – From what I understand, did PBS have the same equipment that they used? They didn't get any newer equipment, so basically it was even all the way?

Jeanette Romano – They each had new equipment, yes.

Councilmember Clemons — Due to the fact that the services are when you have service, you've got to have service to the people and when we don't get the service to the people then we get complaints. That means it makes your job harder and it makes us (the board) get calls. So I would want to spend the extra money and have peace of mind and know that we are doing a good job. They could have done the same job that they did but they came in here and kind of took it to another level, I think. Keeping the stuff clean and doing the job with less complaints. That's all I've got to say.

Councilmember Long – I have a question for Jeanette on John Minear. I was just curious, before John quit, did he ever get in his truck and go around and follow the company that has the bid and trail them and make sure they did everything?

Jeanette – He was actually at the site, he viewed it at the compost site. He did speak with Bob's Tree Service about it and Bob's did say that he would remedy it. He didn't see him at the site. He didn't say if he was following them or not.

Chairman Hamm – On the motion, I'd like a roll call vote. That motion has been made by Councilmember Clemons and seconded by Vice Chairwoman Cid to award the contract to PBS.

Cliff Duggan – Based on the factors that were listed?

Chairman Hamm – Based on the facts, yes.

BOARD OF DIRECTOR'S MEETING REPORT FROM JEANETTE ROMANO JANUARY 17, 2019

• 2019 District Board Meeting Dates: January 17; March 21; May 16; July 18; September 19; and November 21; all beginning at 6:00 pm in the Auditorium at the Lake County Government Center.

CAPS - Caps to Benches

Kiera Hagerman, Education and Public Information Programs Manager will present. The District will be sponsoring the CAPS program again this year. The program will be announced next week with registration beginning in March. Green Tree Plastics has made a few changes to their program this year and is requiring all groups to actively include children /students in the collecting/sorting process. We will pass information on to our groups prior to registration and require each group to verify that the entire collection is child-centered. The Team has decided that we need a minimum of 10 groups to participate and have set a maximum of 15 groups in order to stay within the budget. Groups that have collected the required amount of CAPS will drop their CAPS off and pick their bench up the third week of June 2019.

Composting Operations - Gary Compost Facility Update

- Mobile Office/Storage Trailer As approved by the Board in November, the trailer was purchased from Pac Van and delivered in December. The electric was installed by Meade Electric in January. Inspection of electric installation is scheduled for January 23, 2019. NIPSCO will then install a meter and the Team will be able to use the trailer.
- Old Leaf Vacs (2) At the November meeting the Board approved the sale of this surplus property. The Notice for Solicitation of Bids Sale of Used Leaf Vacs was solicited from at least 3 companies and sealed bids were due today, January 17, 2019. Cliff Duggan, Director of Business Operation/Governmental Affairs will present his findings.

Drop Off Recycling Centers/Program

- The newly reconfigured recycling containers will continue to be delivered to the recycling center locations. Due to the weather staff will not be located at the recycling centers to speak with the public about "Recycle Right". The sign at the Cedar Lake Recycling Center has been updated.
- The Recycling Center at the Lake County Government Center received two reconfigured recycling containers only to have the locking mechanism broken by someone trying to open the lid.
- The centers continue to experience heavy contamination and overage, some more than others. Staff has reached out to the communities, where the recycling centers have been most affected by contamination and overage and requested a meeting with town officials to share ideas.

- Staff met with Waste Management to discuss the program challenges and placement of reconfigured recycling containers; Cedar Lake and Lake County Government Center are scheduled next for reconfigured recycling containers.
- o At the July 2018 Board meeting, Councilmember Ryfa requested staff prepare a report of the program costs for the January meeting. Staff prepared an analysis from the continued review of the program, including contamination and overage costs. The analysis is included in the Board packet.
